The premises operates entirely indoors on a single level, featuring an open-plan layout designed for optimum safety, supervision, and crowd management. The internal layout is divided into three primary zones:

Golf Simulation Zone: This area contains six individual, state-of-the-art indoor golf simulator bays. Each bay is structurally partitioned and enclosed on three sides to ensure customer safety during use.

Lounge and Dining Area: Adjacent to the simulator bays is a comfortable lounge and dining area accommodating up to 150 covers. Seating consists of a mixture of fixed booths and loose tables and chairs. A dedicated kitchen/prep area is located to the rear of the venue, serving a menu of freshly prepared pizzas and premium bar snacks.

Bar Servery: A single, prominent bar servery is centrally positioned to service both the lounge covers and the golf bays. The bar will dispense a curated selection of draught and bottled beers, wines, spirits, and soft drinks.

Facilities: Customer toilets, including fully accessible facilities, are located towards the rear of the premises. Back-of-house areas include a secure stockroom, cellar, and staff office, all of which are strictly off-limits to the public.

Please Note: This application is strictly for the on-premises supply of alcohol only. There is no outdoor seating, pavement cafe, or external consumption area included in this application. All alcohol sold will be consumed entirely within the internal perimeter of the premises.

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

A comprehensive staff training programme shall be implemented and maintained. All staff involved in the sale or supply of alcohol will receive training prior to serving customers, covering the responsible sale of alcohol, underage sales prevention (Challenge 25), proxy sales, and dealing with intoxicated patrons.

Refresher training shall be conducted at least every 12 months, with written records kept on-site and made available to the Police or Licensing Authority upon request.

A designated premises supervisor (DPS) or a personal licence holder shall be available or easily contactable at all times the premises is open for the sale of alcohol.

Substantial food pizzas and bar snacks and non-alcoholic beverages shall be available throughout the hours that alcohol is offered for sale.

b) The prevention of crime and disorder

A digital CCTV system shall be installed and maintained in good working order.

Cameras shall cover all public internal areas, including the bar servery, lounge area, golf bays and the entrance/exit points.

CCTV footage shall be securely stored for a minimum of 31 days and copies made available to the Police or an authorized officer of the Licensing Authority within 24 hours of a lawful request.

An Incidents and Refusals Log (either written or digital) shall be kept at the bar. This log will record all instances of refused alcohol sales, ejections, or public disorder, and will be checked and signed by the DPS monthly.

No customers carrying open bottles, cans, or glasses of alcohol shall be admitted to the premises or allowed to leave the premises with them.

c) Public safety

The maximum capacity of the premises (including staff) shall not exceed 150 people

Fire safety equipment, including extinguishers, smoke detectors, and emergency lighting, shall be maintained in accordance with the Regulatory Reform (Fire Safety) Order 2005, with regular testing logs kept on-site.

All exit routes, internal lobbies, and emergency exits shall be kept clear of obstructions at all times.

The 6 indoor golf simulator bays shall be structurally partitioned and operated in accordance with the manufacturer's safety guidelines to ensure a safe distance is maintained between players, bystanders, and staff.

A fully stocked first-aid kit shall be kept on the premises and at least one first-aid trained member of staff shall be on duty during peak operational hours.

d) The prevention of public nuisance

Music played inside the premises shall be limited to background levels only, distributed via the 6 indoor bookshelf speakers, to ensure it is non-intrusive to golfers and does not cause a nuisance to neighboring properties.

Prominent, clear signs shall be displayed at the exit requesting customers to respect local residents and commercial neighbors by leaving the premises and the area quietly.

All waste, including empty bottles and commercial refuse, shall be stored securely and shall not be disposed of or placed in external bins between the hours of 22:00 and 08:00 to prevent noise disturbance.

The management shall ensure that the area immediately outside the front entrance is kept clean, tidy, and free of litter associated with the business.

e) The protection of children from harm

A Challenge 25 proof of age scheme shall be operated at the premises. Any person attempting to purchase alcohol who appears to be under 25 years of age will be required to produce an approved form of identification a photocard driving licence or passport no photo of document will be accepted.

Challenge 25 signage shall be prominently displayed at the main bar servery and entrance.

Children under the age of 16 shall only be permitted on the premises if accompanied by a responsible adult.

 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets

consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

 12. An applicant's agent (for example solicitor) may sign the form on their behalf provided that they have actual authority to do so.
 13. Where there is more than one applicant, each of the applicants or their respective agent must sign the application form.
 14. This is the address which we shall use to correspond with you about this application.
 15. Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be issued to an individual or an individual in a partnership which is not a limited liability partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have the right to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

They do this in one of two ways:

- 1) by providing with this application, copies or scanned copies of the documents which an applicant has provided, to demonstrate their entitlement to work in the UK (which do not need to be certified) as per information published on gov.uk and in guidance.
- 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Home Office online right to work checking service.

As an alternative to providing a copy of original documents, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth, will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be shared digitally. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copies of documents as set out above.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.
