1. This application must be signed, in the case of:
 - i) an individual, by that individual;
 - ii) a partnership, by every partner;
 - iii) a limited company or other incorporated body, by the Secretary or other person authorised to sign on behalf of that body;
 - iv) an unincorporated association, society or similar body, by its duly authorised agent, the application being accompanied by a certified copy of the agent's authority.
2. Any subsequent proposal to change any of the particulars given on this form must be immediately notified to the Trading Standards & Veterinary Services Director at the address given above.
3. If any person knowingly or recklessly makes a false statement or omits any material particulars in this application, he shall be guilty of any offence for which the maximum penalty is level 5 on the standards scale (currently £5,000).
4. The registration fee of £150 is payable to the Corporation whether the application for registration is granted or not.
