



## Licensing Act 2003

### Premises and club premises certificates – new applications, full variations and annual fees

The licence fees for premises licences and club premises certificates are based on the rateable value of the premises and fall within payment bands A – E as indicated in the table below:

<b>Band</b>	<b>Rateable Value</b>	<b>New Application/ Full Variation</b>	<b>Annual Fee</b>
A	£0 - £4,300	£100	£70
B	£4,301 - £33,000	£190	£180
C	£33,001 - £87,000	£315	£295
D*	£87,001 - £125,000	£450*	£320*
E*	£125,001 and above	£635*	£350*

#### **\* Multiplier fee for Bands D and E**

Premises which fall into bands D or E and the main business activity is exclusively or primarily the sale or supply of alcohol for consumption on the premises, have to pay an additional 'multiplier' fee. The total fees payable are:-

<b>Band</b>	<b>New Application/ Full Variation</b>	<b>Annual Fee</b>
D (£450 x 2)	£900	£640
E (£635 x 3)	£1905	£1050

## **Minor Variations**

The fee for a minor variation for all premises is £89.00.

## **Large Scale Premises**

Premises which allow for an accommodation figure in excess of 5,000 people will have to pay an additional fee based on the number of people. These fees apply to new applications, variations and annual fees.
