

The Licensing Act 2003 requires applications and notices to be served on various public bodies known as 'responsible authorities'. Responsible authorities are entitled to make representations to the licensing authority in relation to an application for the grant, variation, transfer or review of a licence, certificate or notice.

\*the Licensing Authority will consult with those responsible authorities it considers necessary depending on the detail of the minor variation
