# The City of London (Electric Scooter and Pedal Cycle Parking) (Amendment No. 3) Order 2025

Made: 23<sup>rd</sup> January 2025

Coming into operation: 27th May 2025

The Common Council of the City of London Corporation, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(**a**) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(**b**), and of all other powers thereunto enabling hereby make the following Order:-

- 1. This Order may be cited as The City of London (Electric Scooter and Pedal Cycle Parking) (Amendment No. 3) Order 2025 and shall come into operation on 27<sup>th</sup> May 2025.
- 2. In this Order, "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, reenacted by or as having effect by of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Electric Scooter and Pedal Cycle Parking) (No. 1) Order 2022 (as amended) (c) shall have effect as though:-
  - (a) the provisions of that Order shall apply to the items in Schedule 1 to this Order as if those items were in Schedule 5 to that Order;
  - (b) the item numbered 7 in Schedule 5 in The City of London (Electric Scooter and Pedal Cycle Parking) (No. 1) Order 2022 is hereby revoked;
  - (c) the item numbered 5 in Schedule 6 in The City of London (Electric Scooter and Pedal Cycle Parking) (No. 1) Order 2022 is hereby revoked;
  - (d) the items numbered 5 and 6 in Schedule 7 in The City of London (Electric Scooter and Pedal Cycle Parking)(No.1) Order 2022 are hereby revoked; and
  - (e) the item numbered 5 in Schedule 5 in The City of London (Electric Scooter and Pedal Cycle Parking) (Amendment No. 2) Order 2024 is hereby revoked.

#### **EXPLANATORY NOTE**

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order further amends The City of London (Electric Scooter and Pedal Cycle Parking) (No. 1) Order 2022 (as amended), in the City of London as follows:-

#### **Finsbury Circus:**

- (a) revokes the Electric Scooter and Cycle Hire Pedal Cycle Parking Place on the inner kerbline of the rotunda near the south entrance to the gardens.
- (b) revokes the Electric Scooter and Cycle Hire Pedal Cycle Parking Place on northwest side of the inner kerbline of the rotunda north-east of the west entrance to the gardens.
- (c) revokes the Pedal Cycle Parking Place on the inner kerbline of the rotunda either side of the south entrance to the gardens.
- (d) revokes the payment parking places on the outer kerbline of the rotunda on the northern side.
- (e) introduces an Electric Scooter and Cycle Hire Pedal Cycle Parking Places on the inner kerbline of the rotunda:
  - (i) from a point 6 metres south of the extended southern kerb-line of the eastern arm of Finsbury Circus south-westwards for a distance of 15 metres:

- (ii) from a point 4 metres south of the western entrance to the gardens, clockwise for a distance of 15m.
- (f) Introduces an Electric Scooter and Cycle Hire Pedal Cycle Parking Places on the south side of the eastern arm, from a point 10 metres west of its junction with Blomfield Street westwards for a distance of 11 metres.
