# The City of London (Free Parking Places) (Disabled Persons) (Amendment No. 7) Order 2025

Made: 23<sup>rd</sup> January 2025

Coming into operation: 13th February 2025

The Common Council of the City of London Corporation, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(**a**) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(**b**), and of all other powers thereunto enabling hereby make the following Order:-

- 1. This Order may be cited as The City of London (Free Parking Places) (Disabled Persons) (Amendment No. 7) Order 2025 and shall come into operation on 13<sup>th</sup> February 2025.
- 2. In this Order, "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, reenacted by or as having effect by of any subsequent enactment.
  - 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Free Parking Places) (Disabled Persons) (No. 4) Order 2013 (as amended by The City of London (Free Parking Placed) (Disabled Persons) (Amendment No.1) Order 2021 (c) shall have effect as though:-
    - (a) the provisions of that Order shall apply to the items in Schedule 1 to this Order as if those items were in Schedule 2 to that Order:
    - (b) the item numbered 102 and set out in Schedule 2 to that Order is revoked.

#### **EXPLANATORY NOTE**

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order further amends The City of London (Free Parking Places) (Disabled Persons) (No. 4) Order 2013 (as amended by The City of London (Free Parking Placed) (Disabled Persons) (Amendment No.1) Order 2021), in the City of London in:-

- (a) **Moor Lane** to revoke the two disabled persons parking places on the south-east side adjacent to the north-west side of No. 21 Moorfields;
- (b) **Fore Street** to introduce a disabled persons parking place on the south side adjacent to the north side of No. 1 London Wall Place.
