The City of London (Waiting and Loading Restriction) (Amendment No. *) Order 202*

The Common Council of the City of London, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(**a**) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(**b**), and of all other powers thereunto enabling hereby make the following Order:-

- 1. This Order may be cited as The City of London (Waiting and Loading Restriction) (Amendment No. *) Order 202* and shall come into operation on **.
- 2. In this Order, "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Waiting and Loading Restriction) (Consolidation No. 2) Order 2021(c) shall have effect as though the items in Schedule 1 to that Order numbered 44, 105, 136 and 137 there were substituted the items similarly numbered and set out in Schedule 1 to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order further amends The City of London (Waiting and Loading Restriction) (Consolidation No. 1) Order 2021, in the City of London, in:-

- (a) Black Friars Lane to:-
 - (i) introduce an 'at any time' waiting restriction on the east side, at the junction with Queen Victoria Street northward for 8.4 meters;
 - (ii) introduce an 'at any time' waiting restriction on the west side, at the junction with Queen Victoria Street northward for 9.5 meters;
 - (iii) revoke the existing '7am to 7pm Mon to Fri and 7am to 11am Sat, any such day not being Christmas Day, Good Friday or a Bank Holiday' waiting restrictions for the lengths described in (a)(i) and (a)(ii) above.
- (b) Cullum Street to:-
 - (i) introduce an 'at any time' waiting restriction on the east side, at the junction with Fenchurch Street northward for 7.4 meters;
 - (ii) introduce an 'at any time' waiting restriction on the west side, at the junction with Fenchurch Street northward for 8.4 meters;
 - (iii) revoke the existing '7am to 7pm Mon to Fri and 7am to 11am Sat, any such day not being Christmas Day, Good Friday or a Bank Holiday' waiting restrictions for the lengths described in (b)(i) and (b)(ii) above.
- (c) Furnival Street to:-
 - (i) introduce an 'at any time' waiting restriction on the east side, at the junction with Holborn southward for 7 meters;
 - (ii) introduce an 'at any time' waiting restriction on the west side, at the junction with Holborn southward for 7.5 meters;
 - (iii) revoke the existing '7am to 7pm Mon to Fri and 7am to 11am Sat, any such day not being Christmas Day, Good Friday or a Bank Holiday' waiting restrictions for the lengths described in (c)(i) and (c)(ii) above.
- (d) Garlick Hill to:-
 - (i) introduce an 'at any time' waiting restriction on the east side, at the junction with Cannon Street and Queen Victoria Street southward for 7.6 meters;
 - (ii) introduce an 'at any time' waiting restriction on the west side, at the junction with Cannon Street and Queen Victoria Street southward for 6.3 meters;
 - (iii) revoke the existing '7am to 7pm Mon to Fri and 7am to 11am Sat, any such day not being Christmas Day, Good Friday or a Bank Holiday' waiting restrictions for the lengths described in (d)(i) and (d)(ii) above.
- (e) Tallis Street to:-
 - (i) introduce an 'at any time' waiting restriction on both sides, at the junction with Temple Avenue eastward for 7.8 meters;
 - (ii) revoke the existing '7am to 7pm Mon to Fri and 7am to 11am Sat, any such day not being Christmas Day, Good Friday or a Bank Holiday' waiting restrictions for the lengths described in (e)(i) above.

(f) Temple Avenue to:-

- (i) introduce an 'at any time' waiting restriction on the east side, at the junction with Tallis Street northward for 2.2 meters;
- (ii) revoke the existing '7am to 7pm Mon to Fri and 7am to 11am Sat, any such day not being Christmas Day, Good Friday or a Bank Holiday' waiting restrictions for the lengths described in (f)(i) above.
