If you wish to reproduce an oil painting from Guildhall Art Gallery's collections, then please find the artwork on the [ArtUK website](#). To license a high-resolution image please click the shopping trolley icon under the image and then 'buy an image license' and select your usage criteria. Once you have purchased the license you will be supplied the high-resolution file. This process is managed by [ArtUK](#).

In certain circumstances you will need to apply to the Art Gallery directly using this form. This applies when:

- the artwork is still in copyright
- the artwork is unavailable on the ArtUK website (works on paper, photographs, sculptures, and other media)
- you wish to amend the image (a crop or adaptation of the image)
- where none of the licenses on ArtUK match your intended use

You will then be advised of the relevant fee and method of payment (if payment is to be via invoice request, please supply your order number/ official reference for inclusion on our invoice _____).

You can also purchase a digital or physical version of the picture from Collage, however digital purchase does not include a reproduction license and you must still complete this form.

Once payment has been received and reproduction approved, the form will then be returned to you as a record that permission has been given.

Conditions

When permission has been granted, permission applies to the one occasion only. If you wish to reproduce the item(s) again, you must make a new application.

Acknowledgement must be made to: '**Guildhall Art Gallery, City of London**' unless you are advised otherwise.

Complimentary copies will be required for books, journals, book jackets, CD/video covers, invitations, menus, commercial films and videos.
