Introduction to the Business Guide

This guide is a key finding aid to help researchers unlock the rich and substantial business archives of international importance held by London Metropolitan Archives. The purpose of the guide is to enable researchers to identify particular collections through a summarised list arranged alphabetically by organisation name. The entries are also indexed by trade and geographical remit (where interests were held outside the United Kingdom). Researchers can navigate to the [online catalogue](#) for detailed information on particular collections of interest.

What collections are covered by this guide?

The business records held by London Metropolitan Archives are those of businesses mainly based in the "Square Mile" of the City of London and in the wider Greater London region. The business records covered by this guide range from the archives of individual craftsmen and tradesmen, from the fifteenth century onwards, to those of very large companies with national and global interests, from the eighteenth century onwards. Records of important national and international organisations involved with the regulation, promotion, and representation of business activities are also included in this guide (more information on collection strengths can be found on our website [business collections page](#)).

The City of London has developed into a national and international commercial and financial centre. Consequently, records of many City-based businesses and related organisations have a vast geographical spread both in the United Kingdom and overseas. This global significance is indicated by the extent of the geographical index which highlights and direct researchers to companies which had interests in specific countries.

The content of the archives of many City-based businesses have little connection with the City of London as a geographical area, beyond being produced by a City head office, they document "the City" as a financial institution in a world-wide market.

Archives of some businesses based outside London are held due to acquisition by or association with London-based firms.

What collections are not covered in the guide?

- This guide covers business archives which contain records of active trading.
- The guide does not include sources about particular businesses which appear in other non-business archive collections.
- The guide covers records of catalogued business collections. To search for summary details of uncatalogued holdings and recent deposits please visit the former National Register of Archives now available on The National Archives Discovery search website – <http://discovery.nationalarchives.gov.uk/> (select 'advanced search' and click on 'record creators' tab).
- The activities of craftsmen and tradesmen within the City of London were theoretically regulated and protected by the City livery companies and associated trade guilds, whose records are covered by a separate Livery Company Guide publication (see staff for details).
- Businesses for which only title deeds and/or partnership deeds survive are excluded, with the exception of pre-1800 partnership deeds, which may be the only evidence of the existence of the business concerned. Post-1800 partnership deeds can be traced through the catalogue;
- Many solicitors' firms' collections consist of client records only; solicitors' firms are only entered in this guide where business records of the solicitors themselves are held;
- The guide does not include businesses whose records are only held by other archive repositories. However, where records are split between London Metropolitan Archives and other repositories, details have been included.

How do I use the guide?

The guide consists of a main alphabetical list of company names containing summary entries on holdings; with two related trade and geographical indexes. Researchers can browse the alphabetical list, or use the trade and/or geographical index to identify entries within the alphabetical list. Researchers should then consult the online catalogue for further details on specific collections using the collection reference code(s) given in the guide.

The main A-Z alphabetical guide

The main part of the guide is arranged by company name with summary entries on holdings. It is not possible, within the format of this guide, to describe fully the scope and nature of the collections. Full catalogue entries however can be found in our [online catalogue](#).

Standard entries in the guide consist of the following layout:

A-Z by business name

COMPANY TITLE, trade title, business address(es) (with dates of residence); name changes (with date ranges of name changes).

Details of amalgamations, takeovers and connections between companies together with any other essential information.

Date range of the records held (note: details are given if the collection is small) Reference code(s).

Details of any access restrictions or related entries

The address of each business is given, together with changes of address and dates of change, if known. The use of the term "successively" is used to simplify this information where numerous short-term changes took place or where movement dates are uncertain.

Where the name of the firm is that of a private individual, it will appear in the form of ABBOTT, Robert. Where the name is of a private individual trading as a company it will appear in the form A HUNT AND COMPANY

Records of any unidentified businesses are listed under 'U'.

It is worth noting there are numerous records of traders' associations and related organisations in the archives of the London Chamber of Commerce which have not been listed separately in this guide.

Trade subject and geographical indexes

The entries in the main alphabetical guide are indexed by trade subject(s) which businesses were involved, and by geographical area(s) in which the businesses concerned operated where this was outside the United Kingdom.

The indexes are arranged by heading, then an alphabetical list of names.

What access restrictions apply to business archives?

Many business collections are subject to 48 hours notice for access. This restriction is not noted in the main guide but is noted AT FILE LEVEL in the online catalogue.

Access to a number of collections is partially or wholly restricted. An alert is given in the guide and details in the fonds level online catalogue. Permission is usually required from the depositor for access to such collections. However, full details can be sought from staff.
